SEASON TICKET TERMS AND CONDITIONS OF USE

- The Season Ticket is valid for one year from the date of issue.
- The Season Ticket covers admission to Dalscone play area and Dalscone Farm Park for 12 months from the date of issue. Please note: Dalscone Farm Park is only open from Easter to the end of October.
- The Season Ticket may only be used by the named card holder(s) and is not transferable.
- Dalscone Farm reserves the right to close or alter opening times without advance notice. Please phone in advance if you are unsure.
- On busy days, Dalscone Farm reserves the right to operate a waiting list in which all visitors and Season Ticket holders may have to sign in. This is on a strictly first come, first serve basis. In other words, being a Season Ticket holder does not entitle you to advance to the front of the queue.
- The Season Ticket must be shown on each visit to gain admission to Dalscone Farm, otherwise normal admission will be charged.
- There is no restriction to the number of visits Season Ticket holders may make during the year. However, it is not valid for special events such as children's parties.
- Lost Season Tickets must be reported immediately and may be replaced by contacting us on 01387 257546.
- If the original Season ticket is found it must be returned to Dalscone as soon as possible.
- Cardholders' details will be entered onto our database. This is used only to inform you of events; renewal dates etc and will NOT be passed on to anyone else. If you wish your details to be amended or removed from this list, please contact us.
- The card remains the property of Dalscone Farm at all times and may be withdrawn in the event of misuse.
- Please note: only food purchased in the café may be consumed in the café. Any food not purchased in the café may be consumed at the picnic tables provided outside in the farm park during the summer season.
